#### Formal requirements for Proposals

Please submit your proposal for the computer equipment purchase, including the following:

- Detailed specification
- Prices (offered in EUR, without and with VAT) with the discount for quantity
- Delivery time
- Support and warranty details
- Other terms and conditions

Participants may submit offers for the entire scope or only specific lots of their choice:

- Lot 1: Machine Learning Servers and Peripherals
- Lot 2: Laptops
- Lot 3: Monitors
- Lot 4: Graphics Cards
- Lot 5: Power Supplies

Offers shall be binding for at least 1 month.

### Specification:

• In Attachment 1, a detailed specification is provided. The offer should primarily consist of the specified components. If the bidder is unable to supply a specific component, an alternative may be proposed with a clear explanation.

## Payment conditions are:

 Prices are due for payment 30 days after receipt of a proper invoice complying with applicable tax law.



Additional contractual requirements are:

- Uhura Solutions shall have a termination right in case the termination is requested by the competent supervisory authority.
- Applicable law shall be Montenegrin law. Legal venue shall be Podgorica, Montenegro.
  Place of Delivery: Podgorica, Montenegro. Delivery Time: 3 months.

#### Selection procedure
